**RE: Rene Rutagungira and Kagame's Criminal Networks**

I am taking this opportunity to write to you again as a concerned African, who is a citizen of Rwanda and East Africa.

At first I was surprised, shocked in fact, by the release of Rene Rutagungira. Rutagungira is a Rwandan of known criminal history who has acted on behalf of the Rwandan state to inflict death, kidnappings and disappearances to many Rwandans and Ugandans in Uganda. My first instinct was to take this as a clear miscarriage of justice.

On second thought, I realized that we live in dangerous and extra-ordinary times. The times require navigating the complex terrain of balancing the requirement for justice, and those for Uganda's national interests and regional stability.

You stated it clearly in your public letter to Kagame, that you have a problem with Rwandan agents having a free hand in Uganda, behind the back of your Government. Of the agents that Rwanda has deployed in Uganda to engage in killing Rwandans and Ugandans, none has been as notorious and effective as Rutagungira. Working under close supervision of Dan Munyuza (Rwanda's Inspector General of Police), General James Kabarebe (until recently the Minister of Defence, and now Kagame's Senior Advisor), and the much dreaded DMI, Rutagungira is part of a vast criminal network that Kagame runs to keep his bloody dictatorship afloat. Everything Kagame has said and done since Rutagungira was arrested in Uganda proves that he was the most important asset who knew too much.

Yet, I would like to put on public and historic record, that Kagame is not one to make deals he will honor. His default position is promise breaker, conspirator, pathological liar, serial killer, regional bully and warlord-all folded into one.



Nothing you could possibly offer that will quench his insatiable thirst for innocent blood. A brief lull, based on his tactical needs, normally precedes his hand of vengeance striking at those he has conveniently labeled enemies.

Here are a few facts to illustrate.

He signed the Arusha Peace Agreement, only to assassinate the other signatory, President Juvenal Habyarimana alongside the President of Burundi, Cyprian Ntaryamira.

He co-orchestrated the rise and instalment of President Laurent Kabila of the Democratic Republic of Congo only to assassinate him once he (Kabila) resisted absolute control from Kigali.

He has waged wars, direct and proxy, against DRC, Burundi, Angola, Zimbabwe, Namibia and fought Ugandans troops in Kisangani (DRC).

He has picked quarrels with South Africa and Tanzania,.

He imprisoned and humiliated President Pasteur Bizimungu, a Hutu leader within RPF, just to upgrade himself from Vice President to President.

He condemned RPF's Chairman, Alexis Kanyarengwe, to a marginal existence until he died a disappointed man.

He has waged a protracted war of attrition against his comrades in RPF and RPA, to the extent that none of his fellow leaders can be found anywhere near the structures of power in Rwandan society today.. Dozens of RDF Generals have indeed become an endangered species, now perpetually on *agatebe*, hoping against hope that one day Kagame will wake up in good spirits to offer them something to live on. Many RPF leaders and members now languish in what you once described as a stale life of silence and inaction that no revolutionary should ever wish to live. Patrick Mazimpaka and Dr. Jacques Bihozagara, compatriots of mine in RPF's diplomacy during the struggle died hungry and abandoned.

He assassinated many RPF and RPA comrades, including, among others Seth Sendashonga and Patrick Karegeya, and shamelessly gloats in public about it.

He has committed genocide against the Hutu community, imposed group guilt and banished them to a second-citizen status.

With maximum brutality he has divided the Tutsi community to levels never witnessed before, endangering their lives now and in future.

He has forgotten Rwanda's survivors of genocide ( both Tutsi and Hutu), the widows and orphans of fellow comrades who died striving for a united and free Rwanda, even as he amasses hundreds of millions of dollars in a life of scandalous luxury, and squanders billions in a fake developmental state.

His toxicity has inflamed, and now threatens to destroy, the East African Community.

The list of betrayals is very long, Mr.President, for he has even forgotten your help to RPF!



I am taking liberty to make public, for the first time, audio files and transcript, on how Kagame, Kabarebe, Munyuza and Rutagungira planned to assassinate me.

Kagame is the worst thing that has happened to Rwanda and East Africa.


